Recommendations: That the Sub-Committee consider the application for a new Premises Licence and make determinations in respect of this application, namely to: grant the application as submitted, subject to any i) Mandatory Conditions required; modify the conditions of the licence; ii) exclude any of the licensable activities to which the iii) application relates; to refuse to specify a person in the licence as the iv) premises supervisor: reject the application, v) and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added. The decision must be in line with the licensing objectives contained within the Licensing Act 2003.

1. Executive summary

- 1.1 The purpose of the Licensing Sub-Committee meeting is to determine an application for a new Premises Licence at **The Angel**, **South Street**, **Totnes**, **TQ9 5DZ** in accordance with Section 18 of the Licensing Act 2003.
- 1.2 The Licensing Department have received a large number of representations in both objection and support of the application and therefore the application will need to be determined by the Licensing Sub-Committee.

2. Background

- 2.1 The Licensing Authority received an application from The Angel Totnes Ltd for a new premises licence on 15th February 2023. The application is for:
 - Films (indoors):
 - Sunday to Wednesday from 9am to 9pm;
 - Thursday to Saturday from 9am to 10pm.
 - Live and Recorded Music (indoors):
 - Friday and Saturday from 9am to midnight.
 - Late Night Refreshment (indoors):
 - Friday and Saturday from 11pm to midnight.
 - Sale of Alcohol for consumption on and off the premises:
 - Sunday to Wednesday from 10am to 9pm;
 - Thursday from 10am to 11pm;
 - Friday and Saturday from 10am to 11.30pm.
 - All of the above activities during the following Non-Standard Timings:
 - Bank Holiday Mondays and Sunday prior to Bank Holiday from 7am to midnight.
 - New Year's Eve from 7am to 2am.
 - SeaChange Festival (Friday, Saturday and Sunday) from 9am to 1am.
 - Totnes XX Festival (one week in the month of March) from 9am to midnight.
 - Ways with Words Festival (one week per calendar year) from 9am to midnight.
 - International Women's Day (8 March) from 7am to midnight.
 - Totnes Pride (three days in month of September) from 9am to midnight.

The dates of those events that change each year will be notified to the Licensing Department at least three months prior to the event taking place.

- Opening hours:
 - Monday to Wednesday from 7am to 11pm; Thursday to Saturday from 7am to midnight; Sunday from 7am to 10pm.
 - Non-Standard Timings as above, with closing time 30 minutes after licensable activities have ended.

A copy of the application form and plan is attached at **Appendix A**.

- 2.2 The premises is located in the town centre of Totnes, not far from the High Street, in an area with a mix of residential and commercial properties. The premises is a two storey building, the proposed licensed area is the first floor only (see premises licence plan at **Appendix Aiii**). A map of the location is attached at **Appendix B** and photographs of the premises and nearby properties are at **Appendix C**.
- 2.3 During the consultation period, 28 relevant representations were received from local residents in objection to the application and 43 representations were received in support of the application, including one from a local District Councillor. A representation has also been received in objection to the application from Environmental Health. Copies of the representations are attached at **Appendices D, E and F**.

<u>Representations</u>

- 2.4 Issues raised in the representations in objection to the application make reference to all four of the licensing objectives, but there is particular concern in relation to the prevention of public nuisance and prevention of crime and disorder licensing objectives. Noise nuisance from both music and customers coming from within the premises and noise from customers leaving or standing outside of the premises have been raised by nearby residents as a major concern. The narrow street and lack of sound insulation at both the premises and within properties in the area have been noted in many of the representations. Reference has been made to noise disturbance experienced during previous events held at the premises.
- 2.5 Another concern raised is the potential for anti-social behaviour and criminal damage caused by customers of the premises, due to the consumption of alcohol. Some of the representations have mentioned the possibility of rubbish such as empty bottles and glass being left in the road and outside nearby properties.
- 2.6 Access to the premises and traffic concerns have also been noted in many of the representations, due to the narrow road and lack of parking in the area.
- 2.7 The main concerns raised in the representation from Environmental Health (**Appendix D**) relate to the playing of live music and recorded music and how customers will leave the premises without causing a disturbance to local residents. They have requested further information from the applicants to explain how these issues will be addressed, in the form of a noise management plan. Whilst they appreciate the conditions which have been offered to address the prevention of public nuisance licensing objective, they do not believe that they are sufficient to manage noise from music nor noise from customers gathering outside the premises.

- 2.8 Environmental Health have provided a list of the types of measures and conditions which they suggest may help to prevent a nuisance being caused. They have stated that four complaints about noise emanating from the premises have been received by the Council since 2020, from three different addresses.
- 2.9 Representations in support of the application emphasise the strong management controls in place during events held at the premises, particularly how customers are asked to be mindful of local residents and to leave the vicinity quickly and quietly. Also noted is that security staff are used during music events to ensure customers are not causing a nuisance outside in the street and that they smoke away from nearby properties. It has been highlighted in many of the representations that the management are very conscientious in refusing entry where appropriate and follow a strict Challenge 25 policy to prevent underage sales.
- 2.10 During the consultation period the Police requested that four additional conditions were included to promote the prevention of crime and disorder licensing objective, which the applicants have agreed to, see **Appendix G.** These include the condition that the venue will only be open for sale of alcohol when pre-booked events or functions are taking place. This will prevent the premises from being open for the sale of alcohol on other days, such as a public house or bar. Also included is the condition that open vessels will not be taken from the venue and that a risk assessment will be carried out prior to each event to assess the need to use polycarbonate or plastic drinking receptacles. The Police have confirmed that with the inclusion of these additional conditions, they have no objection to the application
- 2.11 Some of the representations in objection to the application make reference to concerns about fire safety and ease of escape in case of emergency. Devon and Somerset Fire and Rescue Service were consulted on the premises licence application. They have confirmed that they have carried out a Fire Safety inspection at The Angel and have made some observations and recommendations for the applicants to undertake. No representation has been received from the Fire Service in relation to the licence application.
- 2.12 Any information contained in the representations which is not relevant to the promotion of the four licensing objectives (see 2.19) cannot be taken into consideration when determining the premises licence application.

Temporary Event Notices

2.13 The premises has been used for events involving the sale of alcohol and provision of regulated entertainment through the use of temporary event notices (TENs). Since March 2022 there have been 12 TENs served for the premises, covering a total of 16 calendar days. The timings and details of these are at **Appendix H**. The event descriptions vary from live music and DJs to theatrical performances, supper clubs, pop up cafés and cocktail bar. The finish times have ranged from 10pm to 1am.

2.14 The maximum number of TENs that can take place at any one premises is 15 per calendar year, covering a total of 21 days (due to changes brought in following COVID restrictions, this has been increased from 15 to 20 TENs and 21 to 26 days for the 2022 and 2023 calendar years – there has been no indication that this will be extended).

The Live Music Act 2012

- 2.15 The Live Music Act 2012 and subsequent amendments, allow the provision of live and recorded amplified music at any premises licensed for the sale of alcohol for consumption on the premises between the hours of 08:00 and 23:00. There is no way to restrict these activities through the premises licence during these hours, other than through the review process once a licence has been granted. Music played in the background (at a level where a conversation can be easily held) is never licensable. Should a licence be granted to include the sale of alcohol for consumption on the premises, live and recorded amplified music will automatically be permitted until 11pm on any day, or until the end of alcohol sales (whichever is earlier).
- 2.16 Therefore the concerns relating specifically to noise from amplified music should only be taken into consideration when the activity will be 'licensable', which in this case would be on Friday and Saturday between 11pm and midnight and after 11pm during Non-Standard Timings. Any conditions relating to noise from music would only be enforceable when the activity is 'licensable'.
- 2.17 As relevant representations in respect of this application have been received, which have not been withdrawn and mediation has not been possible, the Licensing Sub-Committee acting on behalf of the Licensing Authority must make a determination on this application. When coming to a decision, the Licensing Sub-Committee must give consideration to the Council's Statement of Licensing Policy (the Policy) and Home Office guidance issued under Section 182 Licensing Act 2003 (revised December 2022).

Policy and Statutory Guidance

- 2.18 Section 3.1 of the Policy states: The Licensing Authority has a duty under the Act to carry out its licensing functions with a view to promoting the four licensing objectives.
- 2.19 The four licensing objectives are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of public nuisance
 - The protection of children from harm

- 2.20 Section 3.2 of the Policy states: These objectives are the only matters to be taken into account in determining the application and any conditions attached must be appropriate to achieve the licensing objectives. Each objective is of equal importance. A licence will only be granted where the Licensing Authority is satisfied that these objectives have been met.
- 2.21 Section 2.4 of the Policy sets out additional legislation, strategies, policies and guidance to which the Licensing Authority will have regard.
- 2.22 The Guidance issued under Section 182 of the Licensing Act 2003 which was revised and re-published in December 2022 state: The Licensing Authority may not impose conditions unless its discretion has been engaged following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives (paragraph 10.8 of the guidance).
- 2.23 The following responsible authorities are statutory consultees under the Licensing Act 2003:
 - Devon and Cornwall Police
 - Devon and Somerset Fire and Rescue Service
 - Devon Safeguarding Children's Board
 - Devon County Council Trading Standards
 - Devon Drug and Alcohol Action Team, NHS Devon
 - South Hams District Council Planning Department
 - South Hams District Council Environmental Health (Health & Safety)
 - South Hams District Council Environmental Health (Pollution Control)
- 2.24 A representation has been received from Environmental Health.
- 2.25 The Police have agreed four additional conditions with the applicants.
- 2.26 In addition to the above responsible authorities, any person may make a representation in relation to a premises licence application.

3. Outcomes/outputs

- 3.1 When determining an application for a premises licence, particularly when considering appropriate conditions and operating hours, the following sections of the Statement of Licensing Policy (the policy) and Section 182 Guidance (the guidance) are especially relevant:
- 3.2 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early

morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise immediately surrounding the premises may also prove appropriate to address any disturbance anticipated as customers enter and leave (paragraph 2.19 of the guidance).

- 3.3 Sections 5.5.1 and 5.5.2 of the policy states: The Licensing Authority will deal with the issue of licensing hours on the individual merits of each application, but the presumption will be to grant the hours requested unless there are relevant objections to those hours raised on the basis of the licensing objectives.
- 3.4 However, when issuing a licence with hours beyond midnight it is more likely that relevant representations will be made unless there are higher standards of control within operating schedules in order to promote the licensing objectives, especially for premises which are situated near residential areas or in areas where anti-social disorder takes place.
- 3.5 Section 5.5.5 of the policy states: The terminal hours will normally be approved where the Applicant can show that the proposal would not adversely affect the licensing objectives unless, after hearing relevant representation the Licensing Authority believe it appropriate to restrict the hours required due to the nature of the activities and the amenity of the area. If the Licensing Committee or a sub-committee believes that granting longer hours would undermine the licensing objectives, it may reject the application or grant it with appropriate conditions and/or different hours from those requested.
- 3.6 Section 3.8.1 of the Policy states: The Authority recognises the great variety of premises for which licences may be sought. These include theatres, members' clubs, sports clubs, cinemas, restaurants, pubs, nightclubs, cafes, takeaways, community halls, schools and off-licences. The Authority will not restrict access by children to any particular type of premises unless it is considered appropriate to do so in order to protect them from harm.
- 3.7 Section 3.8.6 of the Policy states: When deciding whether or not to limit access to children the Licensing Authority will judge each application on its own individual merits. Examples which may give rise to concern in respect of children would include premises: -
 - where entertainment of an adult or sexual nature is provided
 - $\hfill\square$ where there is a strong element of gambling taking place
 - with a known association with drug taking or dealing
 - where there have been convictions of the current management for serving alcohol to those under 18 years

- where the supply of alcohol for consumption on the premises is exclusive or primary purpose of the services provided at the premises
- where there are unsupervised areas (for example toilets, beer gardens, play zones).
- 3.8 The desired outcome is a determination of the application with reasons provided which relate to the four licensing objectives and when conditions are imposed, that these are appropriate to address the licensing objectives.

4. Options available and consideration of risk

- 4.1 The Licensing Authority may decide to impose additional conditions to address the four licensing objectives, or to amend or remove requested licensable activities. When coming to their decision the Licensing Sub-Committee must give consideration to the Section 182 Guidance and the Statement of Licensing Policy. Reasons must be given which relate to the licensing objectives for any decision made.
- 4.2 The Sub-Committee will need to consider the hours of operation proposed, the effectiveness of the operating schedule proposed by the applicant, the representations received, the location of the premises in relation to residential properties, the history of the management of the premises (if applicable), the evidence provided of any problems in the past, the likely impact of any extension of hours and activities, public transport, taxi availability, the right the applicant has to operate a business and balancing the rights of residents to the quiet enjoyment and privacy of family life. The South Hams relies on tourism, with the population in the district doubling in the summer months with holiday makers both from this country and international visitors who are, in the main, families with young children and retired people – the very segment of society who would perhaps be deterred by anti-social behaviour. These, and any other relevant issues, may be explored at the hearing in so far as it reflects the four licensing objectives.
- 4.3 A decision made by the Licensing Sub-Committee may be appealed by the applicant or any person who has made relevant representations. The right of appeal is to the Magistrates' Court by virtue of Section 181 and Schedule 5 of the Licensing Act 2003. The Magistrates' Court may dismiss the appeal, or substitute its own decision, or send back the case to the Licensing Authority with directions as to how the case is to be dealt with. The Magistrates' Court may make any costs order it thinks fit.
- 4.4 The Licensing Act 2003 contains a provision which enables a responsible authority or any other person to apply to this Licensing Authority for a review of the premises licence once granted. A hearing follows which enables the Sub-Committee to use the

normal powers available, but also to suspend the licence for a period of up to three months or to withdraw it.

5. Proposed Way Forward

- 5.1 That the Sub-Committee consider the application for a new Premises Licence and make a determination in respect of this application, namely to:
 - i) grant the application as submitted, subject to any Mandatory Conditions required;
 - ii) modify the conditions of the licence;
 - iii) exclude any of the licensable activities to which the application relates;
 - iv) to refuse to specify a person in the licence as the premises supervisor;
 - v) reject the application, in line with the licensing objectives (Section 4) contained within the Licensing Act 2003.

6. Implications

APPENDIX A(ii) - Section M of application form

Preventing Crime and Disorder

I have a duty to do all that is reasonably possible in reducing and preventing crime and disorder by attempting to regulate behaviour in and within the immediate vicinity of the venue. We do this by:

participating with Community Safety Partnerships.

preventative measures ie providing efficient service to reduce waiting time at bars can stop levels of frustration rising and reduce aggressive outbursts; clear bottles and glasses from the bar and tables to reduce the number of weapons available should conflict occur; know the customers, acknowledge them and say hello; know the area recognise early signs of trouble and intervene in a friendly manor discourage excessive drinking

- Alcohol sold for consumption off the premises will be supplied in sealed containers only.
- Customers carrying open containers of alcoholic or soft drinks will not be admitted to the premises at any time.
- No bottles will be served that any person may have the intention to drink from.
- An alcohol sales refusal register shall be kept at the premises and be maintained to include details of all alcohol sales refused. The register will include:
 - i. the date and time of refusal
 - ii. the reason for refusal
 - iii. details of the person refusing the sale
 - iv. description of the customer
 - v. any other relevant observations.

The refusals register will be made available for inspection and copying on request of an authorised officer of a responsible authority. All entries must be made within 24 hours of the refusal.

An incident book shall be maintained to record any activity of a violent, criminal or anti-social nature. The record will contain the time and date, the nature of the incident, the people involved, the action taken and details of the person responsible for the management of the premises at the time of the incident.

The Premises Licence holder will implement a drugs policy detailing the actions to be undertaken to minimise the opportunity to use or supply illegal substances within the premises.

Public Safety

I need to demonstrate an awareness and compliance with:

- Fire prevention legislation responsible for carrying out a fire safety risk assessment and implement a fire safety management plan
- Health and safety legislation
- Assess the risk of noise
- Free drinking water
- Special effects should not be used unless full safety controls are in place
- There will be adequate arrangements for first aid provision. A first aid box with an adequate and appropriate supply of first aid equipment and materials will be available for the use of patrons. Suitable protective equipment must be provided to deal with hypodermic needles, blood spillages and other body fluids. Procedures will be in place to ensure that body fluids are dealt with in a safe manner to avoid the risk of communicable disease.
- Exit routes and stairs well maintained, clear and non-slip
- Staff levels should be adequate and suitably trained in emergency procedures
- Regular glass and bottle collection from the public areas should be in operation

- Means of addressing customers that can be heard above the entertainment should be operational in case safety announcements are necessary

Prevention of Public Nuisance

Patrons will be asked not to stand around talking in the street outside the premises or any car park and asked to leave the vicinity quickly and quietly.

Suitable signs at all relevant exits requesting that patrons make as little noise as possible when leaving the premises will be displayed.

The handling of beer kegs, bottles and other similar items will not take place in the late evening, at night and during the early morning when the noise generated could cause a nuisance particularly outside buildings. Deliveries and collections will also not take place during these times.

Bins containing cans or bottles will not be emptied outside after 7pm but must be dealt with the next day during normal office hours.


The Protection of Children from Harm

There will be in place a written age verification policy in relation to the sale or supply of alcohol, which will specify a Challenge 25 proof of age requirement. This means that staff working at the premises will ask individuals who appear to be under 25 years of age, attempting to purchase alcohol, to produce identification. The only acceptable identification documents will be:

- A photo driving licence
- A passport
- An identification card carrying the PASS hologram
- Unless such identification is produced the sale of alcohol will be refused.

This policy will include documented steps taken to prevent adults from purchasing alcohol for or on behalf of children under 18.

The premises shall display prominent signage indicating that a Challenge 25 scheme is in operation.







APPENDIX B - Map of Location

Location of The Angel, South Street, Totnes



Environmental Health Representation in relation to Premises Licence Application The Angel – South Street, Totnes

Thank you for consulting Environmental Health on the premises licence application for the Angel Totnes.

We would like to make a representation on the basis that the information in the application form and operating schedule are insufficient in order for us to determine if the applicant is promoting the licensing objective of prevention of public nuisance.

We have previously received complaints in relation to music from the premises and noise from patrons drinking and smoking outside and in the vicinity of the premises. We appreciate that some of these complaints/incidents may have occurred when the premises were run by the previous occupiers of the Gallery. I have summarised the complaints in the table below for your information.

Since receiving the application we have been in constructive dialogue with the applicants, and they have engaged the services of an acoustic consultant to advise them on what further measures they need to put into place. Unfortunately we haven't been able to conclude our discussion and come to an agreement prior to the deadline for representations. However we will continue to do so prior to any hearing. If sufficient information and, or if noise management conditions can be agreed prior to any hearing then we may be in a position to withdraw this representation.

In total we have received four complaints from three different addresses since 2020.

Our main concerns relate the playing of recorded and live music, and the ways and means that customers will be dispersed from the premises to prevent them creating disturbance on the street from noise associated with groups of people smoking and drinking, especially later at night.

The application lists the following mitigation measures in relation to the licensing objective of the promotion of prevention of public nuisance.

- Patrons will be asked not to stand around talking in the street outside the premises or any car park and asked to leave the vicinity quickly and quietly.
- Suitable signs at all relevant exits requesting that patrons make as little noise as possible when leaving the premises will be displayed.
- The handling of beer kegs, bottles and other similar items will not take place in the late evening, at night and during the early morning when the noise generated could cause a nuisance particularly outside buildings. Deliveries and collections will also not take place during these times.
- Bins containing cans or bottles will not be emptied outside after 7pm but must be dealt with the next day during normal office hours.

Whilst we welcome the measures in relation to disposal of cans and bottles not occurring after 7 pm, we would like to see a clear condition in relation to the times particularly clarification of what normal office hours means, For example no bins will be emptied outside between the hours of 7 pm – 9 am. We would suggest the timing for handling of deliveries and moving of beer kegs outside adhere to a similar timing, but we appreciate that timing of deliveries may sometimes be outside of the applicant's control, and not all deliveries will be in association with a licensable activity. For example food, equipment soft drinks etc.

However these measures are not sufficient, in our view, to manage noise from loud or recorded music nor the noise from people gathering outside the premises and that is why we are making this representation.

In order to be helpful, and as a general guide, other measures and or conditions the applicant may like to consider include some or all of the following:

- Structural measures to prevent noise break out, for example use of sound insulation, noise lobbies, acoustic glazing, keeping windows and doors closed, alternative means of ventilation etc.
- Other Physical measures: Equipment and management of equipment for example positioning of speakers, choice of speakers/amplifiers, rules around use of third party equipment and instruments. Use of noise limiters etc particularly in relation to volume and lower frequency noise.
- Communications notifications to residents of events, and complaint handling procedures, including details of named people responsible for such functions.
- Management plans this is probably the main and best means of control ultimately. How will noise be managed, and by whom, how will you monitor noise etc. How many events will be held, how often, what type of events, will they be booked in advance, who will manage noise during the events if it isn't the DPS or Premises licence holder. What are the dispersal strategies, and how will outside spaces be managed. Will litter including cigarette butts, glasses, and bottles be collected at the end of each event so that the street is clean and tidy?

We would look to the business with the help of their specialist to come up with the measures themselves, as they know their business the best and know what their plans for the use of the premises are.

Dear team,

I strongly object to the licensing application submitted on behalf of this premises.

I already experience considerable noise resulting from the activities at the Angel, [REDACTED] and music can be heard [REDACTED] and whilst I am in the garden. Currently it is at a tolerable level, but there have been issues with late night licences for parties which resulted in disrupted sleep from the noise levels and also on the street when people are leaving the venue.

South street is a quiet residential street with families with young children (I have 2 x daughters). It is totally unsuited to a venue being used in this way. The houses are close together and in close proximity to the venue and as such late licences would result in considerable public nuisance to residents. Having large numbers of visitors to this narrow residential street would result in increased disorder (there is already an issue of drivers using the road without realising it is a dead end) with taxi cabs and drivers attempting to get to the venue. There is likely to be an increase in crime and public safety would be affected by the very nature of the provision of alcohol late at night. It goes without saying that the protection of children may be an issue by increased rates of traffic as well as being affected by music late at night.

I am surprised that the venue thinks that such a licensing application is suitable and trust the council will not approve it.

Objection 2

I am writing to object to this application. This part of South Street is almost exclusively residential apart from the Angel. It is narrow, difficult to access and has no footways. Residents are used to occasional events being held at the Angel but this licence application, if granted, would increase noise and congestion. The street does not have the capacity for more vehicles and attracting more people into the area will be unpleasant for residents, increase the likelihood of criminal damage to parked cars and surrounding residential properties and put the few existing pedestrians at risk.

Access for emergency vehicles is very difficult already and is likely to be made worse by increased activity at the Angel.

I have off street parking accessed through a passage [REDACTED], about 25 metres from the Angel. It is already very difficult to get in and out because of illegally stored wheelie bins left on the street. The turning area outside the Angel is vital for emergency vehicles and will likely regularly become blocked if this application is successful.

I strongly object to any licence being granted that will increase noise in the evenings. This is not a suitable location for on or off sales of alcoholic beverages given the nature of the area.

Objection 4

I am writing to indicate my objection to the license application for alcohol of The Angel TQ9 5DZ, on two accounts:

1. Public nuisance. Opening hours to 12 midnight will provide a public nuisance based on level of sound from music venues and sale of alcohol. Given that this area is a quiet non-commercial area, an earlier (ie., 10pm cessation of all activity would be more appropriate).

2. Due to, in large part, Happy Apple delivery traffic,South Street traffic is already becoming highly congested and is becoming a continual public nuisance to people living on the street. Addition of another commercial entity on the street will increase further this nuisance.

Objection 5

I am writing to state my objection to the proposal for the Angel to host late evening music/refreshment. Whilst early evening films would be acceptable this residential area is totally inappropriate for late night load music and to serve alcohol to midnight.

Objection 6

I am registering my objection to the license application for The Angel Studio in South Street Totnes.

This premises has been used as a gallery and yoga studio for several years. In 2018 until 2020 discos and live bands were occasionally put on under T.E.N.S. licenses. These got progressively later and noisier , with groups of people gathering outside [REDACTED]. When my husband went outside to remonstrate with those standing smoking and talking loudly by our front door he was met with a hostile attitude.

My house is extremely old , not soundproofed and [REDACTED].

I complained to Environmental Health and Sarah Harcombe attended in February 2020 to monitor the noise.

It was agreed that it was too loud, but that was the last event held as Covid began.

The tenancy changed in March 2022 and late night functions began again under T.E.N.S. leading to more complaints from myself and neighbours.

Anti social behaviour.

Due to the lack of adequate toilet provision, nearby properties are used as urinals.

I was informed that The Angel is licensed for 60 persons, they advertise that they can seat 55 persons for pop up kitchen events, weddings etc.

To my knowledge they have one toilet on the premises.

Noise and disturbance due to patrons arriving and leaving, and hanging around in groups outside to smoke, vape, and socialise. After one recent pop up kitchen event I had to clear vomit and cocktail debris from my porch.

I am unable to use my bedroom until everyone has gone home .

After pop up events or hired out evenings ,loading cars ,loud conversations and door slamming late at night disturbs what is a quiet residential neighbourhood.

The Angel responded to complaints saying they will police the front door to prevent problems. That would be extremely difficult as South Street is very narrow, [REDACTED]. There are many courtyards, passages and porches in the area where patrons can loiter.

The present lessees of the Angel have said that they have no intention of fully using this license if granted, but if three months down the line they decided to pass on the tenancy a new owner could have a very different attitude and we could have noise and disruption every weekend and more. They have suggested soundproofing some of the windows in order to cut noise but the premises are extremely old originally a hayloft with slate hanging and timber hung areas, sound emanates from everywhere. During the summer ,windows and the front door are left open as there is no ventilation system for fresh air or the disposal of cooking smells. There will be also be the noise of alcohol deliveries and waste disposal to consider.

Objection 7

To ever it concerns.

It has come to my attention that The Angel in Totnes is applying for permission to stay open for drinks and late-night venues.

Its loud enough when they do their funny Totnes dance sessions during the day.

This has come as a shock and strongly object. This is a quiet residential street with young and elderly people. The idea that this could be allowed to go ahead is ridiculous and having spoken to majority of neighbours they cannot believe this would be allowed to go ahead.

I live it in your hands to make the right decision but I personally strongly object. .

Objection 8

OBJECTION TO NEW PREMISES LICENCE. I refer to the proposed application of 'New Premises Licence' for The Angel Totnes Ltd. South Street, Totnes. TQ9 5DZ

I wish to object to the New Premises Licence Application on the grounds of Prevention of Public Nuisance.

I live directly opposite The Angel and have already experienced loud music at events there late at night, as well as antisocial behaviour, urinating and vomiting in the street both outside our house and in our courtyard, which is related to alcohol consumption.

We have experienced people coming out of The Angel gathering to drink and smoke on our property and have found broken glass in the road and in our driveway which can damage our car tyres.

This behaviour can only get worse and more frequent if a New Premises Licence to serve alcohol is granted.

The premises are situated in the middle of a peaceful, high density residential area. The current owners have historically run an eclectic mix of daytime and early evening activities that have had a relatively low impact upon the day-time life of immediate neighbours. Occasionally, the current owners have run some late-night activities that we understand were permitted under Temporary Event Notice legislation. The latter have included pop-up restaurants and some late-night parties which, with a few exceptions, have had a relatively low nuisance impact and we have tolerated these. Indeed, during the last Christmas and New Year festivities we enjoyed a couple of these events!

The previous late-night events have resulted in levels of noise due to both music and the congregation of highly spirited groups of people outside the premises that we have been aware of. Our home is situated [REDACTED]. The current new Licence Application, if passed in its current guise, would potentially allow an infinite number of late-night noise disturbances, each of which would threaten the tranquillity of ours, our children and many other residents' existence within our homes. Such public nuisance should surely not be permitted.

The current owners have advised that they have no intention to increase the frequency of late-night dining and partying and if this is their intention, then it begs the question as to why they need to seek to operate outside of their current TENs modus operandi. Once granted, there is no guarantee that the current owners will be able to police the activities of those who might succeed them. The granting of a late-night licence, such as has been requested, would set a dangerous precedent within a currently peaceful, high density residential area of our town.

The basic human rights of adults and children alike, to enjoy a peaceful and tranquil home environment, without public nuisance, would be adversely affected should the above-mentioned licence request be granted and as such, sadly, we oppose the granting of an Alcohol Premises Licence on the terms requested.

Objection 10

I am a resident of South Street and wish to voice my concerns about the application for a licence at the above property.

South Street is a residential street, it's close location to the High Street is advantageous but it is, with the exception of a printing shop, completely residential. I already tolerate the noise and smell pollution from the high street commercial properties which back onto my property but think that allowing this Licence will set a precedence for other properties, such as the Old Lion Brewery and the building used as a pop up bakery further up South Street to also request these licences. This will ultimately destroy an important residential area of Totnes.

I know all to well that a licence even to just to 9pm does not stop the noise / smell of the establishment, regardless of promises. The smoking / vaping and outdoor conversations will all infringe on the residents. We already encounter issues with our bins been knocked over, empty

alcohol bottles placed in our doorway, people stood outside talking loudly at 11pm+. Regardless of any notices asking people to be respectful of the neighbourhood, alcohol dulls peoples respect of their environment. The location of these premises is in a narrow part of South Street where the noise will have even more impact on the residential properties.

Hi

I am a little concerned about the proposal re the Angel Totnes Ltd to extend their licensing hours. I am a resident of South Street not directly affected, but on the route out of the street at the opposite end. I understand there is no on living at the Angel, but it is to be used for extended late events. I am keen on a events space but I think the street is primarily residential and anyone late beyond say 10pm would I imagine have the potential to disturb the immediate residents and possibly ourselves.

There are potentially some hijinks after an event and I would consider very late events may be noisy when they wind up, often quite later than last drinks are served. I am not sure what the Angel has applied for but on the notice in the Totnes Times it says 00.00 hours for music and 00.00 for weekends and the Sea Change Festival later at 1 am. The festival goes on often for a week and I think that will be very noisy as it is a narrow road and might well be a nuisance for residents. I understand this was the case with the previous tenant.

Objection 14

Dear sir/madam

We live very close to the premises applying for a licence.

We STRONGLY OBJECT to this application.

South Street is a quiet, narrow residential street in a Conservation Area with houses in very close proximity to The Angel.

The proposal to insert what is effectively a nightclub venue into such a quiet and long-established residential setting is completely inappropriate.

On the previous occasions that residents have found themselves having to tolerate late-night music events from The Angel, the music emanating from the building - which as a historic building is not designed for such activities in terms of fire safety or noise containment - has been unacceptably loud and has caused a significant noise nuisance. The proposal that such events could be a regular occurrence is intolerable.

The sound emanating from the building on such occasions reverberates along the narrow street and carries into all properties within the area, including our own, until late into the night. The noise of attendees leaving the premises in the middle of the night adds to the unacceptable noise levels.

We have previously put up with the occasional use of the building for such activities in the belief that they were very rare, one-off events.

The prospect of having such activities frequently and regularly taking place in such an unsuitable setting until midnight or later is wholly unacceptable.

Apart from the noise nuisance, such use of this venue, incorporating the sale and consumption of alcohol late into the night, brings with it the risk of turning a historic building in a Conservation Area into a magnet for antisocial behaviour, traffic nuisance and the degeneration of a quiet residential street.

We ask you to consider the detrimental effect this application will have to the character of South Street, the conservation of the area and the well-being of residents who live in this area, including children and elderly people, and REFUSE this application.

Objection 16

Dear Sirs

I am a resident in South Street. South Street is a residential street and this activity at The Angel seems to me to be out of character of the street which is solely residential. The Angel, Totnes on their website serve cocktails and food so I assume they already have a licence for these activities. Or do they?

Their website mentions an events venue for supper nights, weddings and other gatherings for up to 55 people with the accompanying drinks and food and a sound system to provide music. These events would require deliveries for the items needed plus the arrival and departure of up to 55 people and possible people spilling out into the street. A sound system would be a public nuisance to the neighbours as will the arrival and departure of people attending these events.

I would emphasise that South Street is solely residential. An events venue such as this with licensing would be a public nuisance with regard to noise pollution, delivery of goods, late night noise of people leaving and sound systems along with people noise. There could be anti social behaviour, possible crime and disorder after an event serving alcohol. The premises are very close in proximity to private residences and they should be able to enjoy a quiet neighbourhood day and night.

I therefore would object to the granting of this licence in South Street.

Regard

I would like to object to the New Premises Licence application at the Angel on the grounds of Prevention of Public Nuisance. This is a residential area in a very narrow one way street with very limited parking. There is a turning area nearby which needs to be kept clear at all times for delivery vehicles as well as ensuring access for emergency vehicles. The noise from within the premises until midnight on two or more nights a week, would undoubtedly spread into the adjacent street after any event. People leaving the venue would disturb this very quiet street particularly those whose houses open directly onto the street. There is also no noise insulation on the Angel which is a listed building.

I therefore urge that this application be refused.

Objection 18

We wish to object to the New Premises Licence application on the grounds of Prevention of Public Nuisance.

The premises are in a residential part of the town and are surrounded by residential properties.

This section of South Street is very narrow with no parking and restricted access for vehicles. There is a turning area which needs to be kept clear at all times for delivery and utility vehicles as well as ensuring access for emergency vehicles.

Granting of this licence would allow noise from within the premises until midnight on two or more nights a week, inevitably spreading into the adjacent street after any event.

Dispersal of attendees, performers and staff after any event would result in additional traffic in this quiet street.

The proposed venue and the surrounding properties are Listed Buildings without suitable noise insulation.

The bedroom in our own property [REDACTED] would be directly affected by late night noise.

There would be no practical way to prevent noisy or inebriated persons accessing our property having left the venue.

We therefore request that this application be refused.

Objection 19

OBJECTION TO NEW PREMISES LICENCE.

Regarding the proposed application of **'New Premises Licence'** for **The Angel Totnes Ltd.** South Street, Totnes. TQ9 5DZ

I object to the New Premises Licence Application for the above.

I live [REDACTED] The Angel which is a historic building and is not suitable for late-night music events in terms of both fire safety and loud noise, and for children living nearby.

Objection 20

Dear Karen Proctor,

I understand from a local community police officer that you are the present Community Environmental Health Officer.

Re: The Angel Totnes Ltd.applying for a New Premises License at The Angel, South St, Totnes, TQ9 5DZ / objections to be received by 15.3.23.

I'm letting you know that I very strongly object to this license being granted and I describe below why this is so.

I moved into my property 15 months ago having considered noise nuisance to be very important. I'm a UKCP reg psychotherapist trained in working with early developmental trauma and abuse and invasive noise affects my ability to work. You will be aware that covid and subsequent transport issues led to an increase in people working from home and their wanting to continue doing so.

There are actually a lot of people now working from home in Totnes on a more permanent basis and noise and socially inconsiderate behaviour became more of a problem over the with levels of amplification used e.g. by buskers. I've been given to understand that the Angel is leased from the Duke of Cornwall who owns the property. I also understand that were a New Premises License to be granted to Nicky and Clare the current leaseholders, they could sell their lease at some future date, it would then become even more difficult for local residents to challenge any further change of usage that could increase noise and anti-social behaviour.

NOISE NUISANCE Please see Nicky and Claire's letter of 5/3.23: (" dear neighbours ", etc.), stating, " we now having secondary glazing on some of our windows".

Its been my experience in living about 50 metres away that this just isn't effective when windows have to be opened in hot weather as was the case last summer. <u>There's no mention of air</u>

<u>conditioning</u> which presumably would be needed were this secondary glazing fully in place. Its been my experience the only entrance door to the Angel is most always left open to provide required fresh air and to encourage patronage from passers by. This the adding to the noise nuisance.

On the several occasions that I've visited and politely asked that the amplification be turned down I've been met with aggressive hectoring by a man running musical evenings there. We local residents have wanted dialogue but have not been accommodated.

Concerns re: Fire: I've been inside the Angel about 10 times and have not been aware of any exit in the event of a fire - other than the stairs down to the street. I understand that the the premises are limited to 60 at any event. I would like to know if there's been a <u>recent</u> assessment of fire risk at the **premises**. i.e. an assessment of fire risk that's happened subsequent to the Angel's expansion into offering food with their musical and cinematic entertainment. 60 people as clientele attempting to leave via the winding stairs in the event of a fire is more than concerning There may well be an additional fire escape that I'm not aware of. I would like to know if there is one. I presume there's no disabled access. I'd also like to know about about the number of toilets available for 60+ people and whether the problem of patrons urinating in South St might be linked with this.

With the more recent expansion of musical events later in the evening, I was pleased that the amplification of music was kept low and at a level I could occasionally live with. Having some advance warning of late night events meant I could arrange to stay with friends outside of South St when it affected my sleep.

However on hearing the noise of screaming children some time before Christmas I went and found several young children running up and down South St. excitedly. We were in fact nearly run down by an irritated cyclist who couldn't see us. I collected the children together and took them back inside the Angel and asked them to fetch a parent. A man came down and I politely expressed my concern that he keep the door closed and not allow them them to play on the street in the dark. He took his children upstairs and completely ignored me. I notice this can be a response from people outside of Totnes who come to stay for short breaks. Being ignored isn't anti- social behaviour, it just indicates an unwillingness to enter into a dialogue about the needs of the community who live here.

Anti-social behaviour.

Loud and abusive language, dope-smoking and urinating are all something I'm aware that other residents have had to tolerate and I've seen this when I've gone out into South St when this is occurring. My cottage is [REDACTED] which affords me some protection from it.

PARKING: I'm aware that parking and is not an issue for those residents with allocated parking space 3-4 at most. There are double yellow lines on both sides of South St and no parking spaces on street. Its an issue for me in that I have to use a car on occasions. I pay a for a expensive yearly permit of approx. £375 though there's often little guarantee of my finding a parking space in local car parks I've taken this up with SHDC but they refuse to acknowledge it as a problem for Totnes residents without parking facilities at their home. I would like to know if the Angel provides any parking for its clientele ?

Prior to my moving into my property f, I saw that the Angel offered yoga hairdressing and some art classes. I am also a professional artist and imagined I might approach Nicky and Clare about organising shows of local artist's work. However, in response to both noise and anti-social behaviour in the street when the Angel expanded its activities; myself and another resident asked to meet with them to explore possible solutions we might find re: these disturbances in a quiet residential street. We were extremely disappointed to be met with derision and some hostility.

My own working background has been in community agency development in the London Boroughs of Camden and Tower Hamlets so I have some familiarity with the problems that can arise within communities and had hoped to open up a mutually beneficial dialogue. This has not been possible. To conclude: I repeat myself in saying that I strongly object to this licence being granted in the face of local residents opposition to it.

I'm aware that some years ago a similar noise disturbance was assessed by the then Environmental Health Protection Officer. She apparently visited and on experiencing it personally, she adjudged it as intolerable.

Objection 21

Dear Sir/Madam,

I wish to register my strong objection to the application for a premises licence for The Angel, South Street, Totnes.

This quiet, residential part of South Street is a wholly inappropriate place to to run a licensed venue offering live music, recorded music, films, 'a really great sound system', 'wedding parties' and 'a cocktail bar'. The street is narrow and echoey, noise made by the Angel has nowhere to go but into neighbouring houses just a few metres away. This corner of South Street is home to a flourishing community of young families, older people and young professionals, we are a creative, socially conscious group, many of us have lived in the area for some time (2008 in our case). We used to enjoy having a quiet artists studio as part of this community but after the sad death of the artist there has been an attempt to change the use from a studio to an entertainment venue. This application would enable the Angel to offer events with alcohol 7-days a week causing immense disruption to our lives and severely affecting our mental health.

My objection is based on the following reasons:

Noise

The Angel is a historic hayloft and its construction (open plan with lots of timber) means that it acts like a large soundbox. Coupled with a powerful sound system in the roof space (which they proudly advertise on their website) means that a large amount of noise is generated and fills the surrounding properties with noise. [REDACTED]. We can't escape the noise anywhere in our house making it incredibly hard to work, be creative or relax. As well as the noise of the music there is also the noise of the audience at events. Inevitably they spill out into the street and as the street is only a few metres wide, this in effect means that they are congregating right outside our windows. On many occasions there has been a lot of swearing and strong language, completely inappropriate for an eight-year old to hear. On the most recent occasion (February 2023), when I pointed this out, I was told to 'f*** off' and 'if you don't like it you should move out'. An unbelievably callous attitude.

Child safety

As I have pointed out above, people who attend events at the Angel often get drunk and then congregate outside our house causing disruption and anxiety to our daughter. [REDACTED]. This is a residential area where a number of young children live, they shouldn't have their lives constricted by a boisterous crowd in the street.

Public nuisance/anti-social behaviour

As stated previously audiences from Angel events tend to congregate outside in the street. As well as the aggravation at being sworn at outside my own house there have been occasions when things have got severely out of hand making me fear damage to my property and nervous of my safety. The last occasion was on Friday 11 March 2022 when a private party at the Angel got out of hand and young people were tearing around the street screaming and throwing bottles. Audiences seem to use the narrow street as the smoking area for the venue, meaning that our front rooms stink of cigarette smoke. The front of our house also gets used as a toilet, rubbish bin and ash tray - really unpleasant to have to clean this up.

Traffic

As previously stated, this part of South Street is very narrow with very little on-street parking. Events at the Angel inevitably need deliveries and this leads to vans and cars parking outside our house and that of neighbours. Not only is this noisy and polluting, it causes congestion. We have missed deliveries and rubbish collection because the drivers couldn't access the street or see rubbish bins, because of the vehicles parked in the street. The street is also something of a cul-de-sac meaning that most vehicles need to three-point turn in a narrow space. Both our property and that of the neighbours have been hit by vehicles turning when they left Angel events late at night.

Fire safety

I am not an expert in this field but it seems that a venue based in a largely timber-lined, open-plan box should have better emergency exits than a single, narrow and steep timber staircase. In summary, I object to this application as the Angel is simply completely unsuitable to be a licensed venue. Events organised by the last two tenants have caused enormous disruption to our lives and damaged our mental health - it would be unbearable for these events to be possible 7-days a week and going on late into the night. There are established venues (Barrel House, Seven Stars, Civic Hall, pubs, church halls) and suitable non-residential areas of Totnes (South Devon Arts Centre in Ford Road) which means there should be no need to harm this area by making The Angel a licensed premises. Thank you taking account of my concerns.

Objection 25

Dear Sir/Ms

I would like to add my concerns to those already expressed about the application that has been made for a premises licence at The Angel, SouthStreet, Totnes.

Formally, this raises concerns around public safety, public nuisance and prevention of crime and disorder.

Given the planned changes in the use of this property, it seems inappropriate for a residential area, situated in a narrow street with awkward access for vehicles, especially from Fore Street. Increased flow of traffic along this street would be problematic, especially at night, and if the nearest carparks

are used, then patrons of the Angel would naturally use South Street on foot. There are no pavements and the street is narrow.

The intended use of the property would lead to numbers of patrons leaving the property late in the evening, and there is a likelihood of noise disturbance from musical events. The time period in which these events are proposed is 9.00am-midnight, or later on Bank Holidays and 'selected celebration days ! They also seek permission to consume alcohol on <u>and off</u> the premises.

The permission being sought seems excessive and inappropriate, as if attempting to create a major hub of activities in this residential area without real consideration of practical issues and the effect on local residents.

I could expand on my concerns, but hope this will give SHDC pause for thought before granting the requested permissions.

Objection 26

Dear Sir/Madam,

We are writing to object to The Angel's application to gain an extended license.

The Angel has provided many fun evenings for us, as well as yoga classes etc. and we would continue to support these relatively infrequent events. However, we are concerned that the frequency of these events will increase, having negative affects on our day-to-day life, as well as our community.

[REDACTED] we often hear noise from The Angel late into the evenings, but as it only tends to be periodically, we have never felt cause to complain. The new application states that the opening hours can increase significantly and we do not want to be hearing these noises on a regular basis.

To clarify we hear the following noise:

Footsteps as people dance

Hum of people talking

Shrills

Music

Smokers talking in the street

People leaving and parting ways with friends or family

People knocking on our door or trying to enter the garden

The owners of the Angel have suggested they get sound proofing. This won't resolve the majority of sound issues. When we consider hotter months windows will be open and soundproofing redundant again.

South Street is a residential street with 1 or 2 small businesses only open during the day. We feel that an establishment to be open late at night is out of keeping with the surrounding neighbourhood. We have a wonderful high street with many locations that could house something similar, if not the same as, the Angel owners intentions with the current venue.

Page 69

In addition, we often receive knocks at our front door at night when The Angel is running events asking if our house is The Angel which is irritating – this could be due to their lack of signage. One can only assume that these would become more regular were the events to increase in frequency.

Although Nicky and Claire have been very cooperative with us over the past year and have assured us that they 'have absolutely NO intention of running a night club, pub, off license or cinema' the word "intention" is variable, unlike the law. Which is our main concern. Their intentions can change over time, the leaseholders themselves may change, with the new owner of the Angel may want to maximise their license.

We are more than happy to support The Angel as it currently stands, and will continue to do so, but unfortunately we cannot support this new licensing application.

As a resident of The Grove, just below South Street, I would like to point out that this is a quiet residential area and the resultant noise and additional anti-social behaviour that will result from this move is unacceptable. Elderly neighbours and those with young children who go to bed before The Angel's proposed closing time will be further disturbed, especially when alcohol and loud music are involved. There have already been incidences of being kept awake due to existing late night events at The Angel and this will only increase.

Totnes High Street has plenty of venues available for events and that is the place for noise, bars and pubs, well away from those of us who choose to live quietly in a town which has been our home for many years, even generations in some cases. As parents of a son who attended KEVICC, attended the Arts Foundation Course locally and who is now at university, I have heard many stories of public nuisance and disorder in the High Street after closing time and this is not something that should be allowed to expand further into quiet residential streets in Totnes.

I very much hope you will listen to local residents' opinions and anxieties and refuse The Angel this additional licence to expand the scope of their events. We need to feel safe in our homes and safeguard the young and elderly in our community.

Objection against new application for Premises Licence for The Angel Totnes Ltd., South Street, Totnes TQ9 5DZ

Dear Licensing Authority

I wish to object ('make a representation') to the above application for a premises license by The Angel. This ludicrous application would be laughable if the implications were not so horribly serious. This quiet residential street is a wholly unsuitable place for an event and late night public entertainment venue.

I am attaching/enclosing some photographs (in a separate email) to demonstrate just how close The Angel is to our home. We live [REDACTED] - and the noise and disruption they have caused since lockdown ended (and before it began) (presumably without a license, as they are only now applying for one) has caused serious disruption in our lives. We have lived in this house **since 2008**, and for many years The Angel Studio was in quiet use as an artist/painter's studio. Sadly the artist died a few years ago and it was after that the trouble began. I must emphasise that this had always been a quiet residential street for as long as we have lived here.

Key to our objection is the fact that South Street is not High Street/Fore Street. South Street is a quiet residential street. This license would completely change the character of the street. When we were house-hunting in 2008 we deliberately chose not to live on the main street. I have a couple of memories of soon after we moved into South Street. A friend asked 'so near to the High St - isn't it noisy?' I replied 'No! All of the revellers head straight up and down the High St and don't turn into South Street'. My mother-in-law sat in our sitting room in the late evening and exclaimed 'You know this is *blissfully* quiet!'. There are plenty of entertainment venues on the High Street - The Barrel House, the Cinema, the Civic Hall, the Seven Stars, church halls, pubs. People can choose to move in next door to them if they want to. We chose not to.

When I read the new application my stomach knotted in pain and I couldn't sleep all night. I've been sliding towards depression and anxiety since June 2021, to which noise and disruption from The Angel is a major contributing factor. I have sent many polite emails and a few polite letters to The Angel pointing out to them the trouble they are causing and making requests for the noise to stop. I'm attaching/enclosing (in a separate email) my collated emails from the past year (I can forward the originals on request if that would help).

[REDACTED]. Music (particularly repetitive beats) from the building [REDACTED] can be very clearly heard in all of these rooms. I have repeatedly told The Angel that we particularly need silence after **7 on school nights (Sun-Thurs) and after 9 on weekends (Fri/Sat)** so that our daughter (let's call her J) can have a normal quiet bedtime. J has complained that she can't get to sleep with the noise. J is in Year 4 at Grove School which is just around the corner, less than 150 child-steps from our front door. She loves her home and her school, is doing very well and has lots of friends, [REDACTED]. My heart breaks when I think how continued noise after bedtime would seriously affect J's ability to rest and to sleep, with all sorts of potential knock on effects on her school life, personality, mental health and future prospects. In addition to the noise of music there are loud voices just outside our windows (conversations are clearly audible from the street, not all of which are suitable for children's ears) and people have a tendency to gather under the lamp-post [REDACTED] and sometimes to smoke, [REDACTED].

Particularly disruptive to us have been a series of dance classes which ran weekly regularly on **Tuesday evenings from 7-9 pm** (I started making a written note on them from March 2022 on reaching the end of my tether but they started long before that). I dreaded Tuesdays for days in advance - just as we managed to get our daughter upstairs to begin a quiet bedtime the repetitive beats began, clearly audible in her bedroom, disrupting her bedtime routine, preventing her from relaxing and going to sleep, with knock-on effects to her waking up for school the next morning and her bedtime routine for the rest of the week. The same noise was also audible in the other front rooms and also from the back of the house - so, no escape in our own home. The way that buildings are arranged at this end of the street creates a hard acoustic space which traps and magnifies noise. The noise is significantly increased when The Angel's window is left open during summer weather - and it was not closed, despite repeated requests.

One night about a year ago (Friday 11 March 2022) things got particularly bad.[REDACTED]. The next morning the street was full of rubbish, filth and broken glass, right up to our doorsteps. Events that would be acceptable at an established High Street venue such as, for example, the Barrel House, or in the industrial estate such as the South Devon Arts Centre, are wholly unacceptable in this quiet residential street. Loud music after bedtime (7 on school nights and 9 on Fri/Sat) is not acceptable. Crowds in a street where there is normally just an occasional passer-by is not acceptable. Loud conversations and smoking just outside our bedrooms is not acceptable. On top of that, there is bound to be some anti-social behaviour and potentially crime and disorder. All this adds up to our constant fear that things may escalate outside our house and in particular, the impact that would have on our child. She is almost 9 and we had hoped that soon she would be able to pop out to her friend's houses or to the shop - potentially drunken strangers just outside our door and therefore knowing where she lives would make this a much more worrying prospect. Even if The Angel's guests were on their best behaviour why should our daughter be woken up late at night by crowds leaving the premises? I myself feel fear and trepidation at the thought of having to make my way through groups of potentially inebriated strangers gathering in the road outside The Angel (as they have during and after past events) just to get to my own front door. For that reason and many others this application brings the threat of **public nuisance**.

A couple of times over recent years I tried contacting both local councils using online forms to complain/for advice about the noise, and to request to see a copy of The Angel's license. I received absolutely no response - not even an acknowledgement - until eventually a neighbour advised me to contact Environmental Health and I received a Statutory Nuisance Diary Sheet in March 2022. Although I have suggested soundproofing as a **temporary** measure until the noise stops for good, I do not believe that it is possible to adequately soundproof the windows and flimsy wooden 'hayloft' walls which directly face our house.

Finally I would like to point out some things on The Angel's website (accessed 9th March). It offers 'a really great sound system with speakers in the apex of the roof!' <www.theangeltotnes.com/pricing/>. The page also shows the objectionable neon sign [REDACTED]. It offers whole weekend hire including up to 11pm on Saturday. I have lost count of the number of times that loud recorded music continues beyond the allocated time. The final image on the same page, which also shows a sound system and drum kits, is basically the view from our doorstep <www.theangeltotnes.com/gallery/>. The space is offered up for wedding receptions <www.theangeltotnes.com/about/> with a bar - how can the guests' behaviour be guaranteed? How can the license applicants police the behaviour of the people who hire the space? If the license applicants are not there in person, what can I do if parties over-run their time limit or there is unacceptable activity in the street? Am I supposed to pop across the road in my pyjamas and challenge the party-goers myself, leaving my child alone in bed? Or call 999? Or is there someone at the council I can phone late at night to deal with the consequences of licenses that they have granted?

The same web page says that the upstairs of the building in question was originally a 'hayloft', which is what it still feels like. How can a building like this be soundproofed and fireproofed? This page also notes that prior to the current tenants the building was an artist's studio and that the current tenants 'took over... transforming the space into a... public venue'. In fact, this change of use is totally unacceptable. Notably, this change of use was publicly announced and actioned before a license application had even been made - what does this say about whether these people's intentions can be trusted? It says that the space is 'in the heart of our community' - what that really means is that it is breaking the heart of a quiet residential street. The 'create your events' page suggests 'a wedding party of 55 for a sit down meal with a bar and a really great sound system' and that you might want to run a cocktail bar for yourself <www.theangeltotnes.com/events/>. This is a completely unsuitable use for this building, for all of the reasons outlined above.

It has been difficult to find the time to write this letter - my husband and I have elderly relatives and the affairs of those who have died recently to organise, as well as jobs and a child. We therefore need to work on these late into the evening, which is made very difficult by the repetitive beats of recorded

music from The Angel (evening events tend to be even louder than the Tuesday dance classes). I am not a lawyer so I might not have phrased this letter correctly but I hope it will be obvious to you that the license application is totally inappropriate and that you will reject it immediately and permanently, so saving us from further stress and heartache.

I work in Environmental Health and we can investigate allegations of noise nuisance in line with the information attached. I will ask our case managers to send you out noise diaries as a first step in this process.

In the case of the Angel, it looks like individuals who hire the premises are sometimes applying for a 'Temporary Event Notice'; these are issued by our licensing

section. Environmental Health can object to them in which case there is likely to be licence review, but I think we would need some evidence of an ongoing problem (eg. via your diaries) before we are likely to make an official objection as there would need to be evidence to inform any review.

We can also monitor events from your home, so do let us know if you are aware of another coming up and we will arrange to monitor it if an officer is available (I can't guarantee that will be the case I'm afraid).

Regarding the overall use of the premises, that is a planning matter. You can contact planning via the links on the website at;

I'm writing with regards to an ongoing noise problem caused by the Angel Gallery, South Street, Totnes. [REDACTED] gave me your contact details, which I'm delighted to have - because I have emailed several times to both the local and district councils over the last two years ago and received literally no response, not even a reply to say who I should contact instead. So I hope I'm onto the right people now!

The Angel Gallery, South Street, has been for the past couple of years been hosting noisy events that are completely inappropriate for a quiet residential street. Their website <<u>https://www.theangelgallery.com</u>> says:

'Live Events

The space is available to hire as a venue for events, from acoustic gigs and inspirational talks to comedy nights and DJ sets. Keep an eye out on social media for our in-house events.'

Such events are completely inappropriate for a residential street and mark a complete change of use from the previous long-term owner, who used the space as a quiet visual arts studio and gallery.

Why were we not consulted about this change of use? What is actually permitted in a residential street, with residential houses directly opposite and on each side? How can we nip this misuse of the property in the bud? What can we do?

The gallery is [REDACTED]. Of most immediate concern is [REDACTED]. Almost every Tuesday there have been noisy dance sessions from 7-9. She is supposed to be in bed at 7 on school nights (Sun-Thurs) and this disturbs her peace and keeps her awake until 9. There have also been noisy events until 11 on many Fridays and Saturdays - my 8-year-old should be able to sleep in peace by 9 o'clock, even on weekends. On top of this, I was gobsmacked to hear that a late license had been granted for this coming Saturday for an event until 1 am!! My daughter thinks that only Santa and emergency workers are awake at midnight - how on earth was this license granted opposite a

house?? The gallery owner has informed me that this particular event has been cancelled due to Covid, but how can ensure that such a license is not granted again?! [REDACTED].

They also brought my attention to their Challenge 25 policy and the need to request relevant identification. I believe in the implementation of these policies they are determined to protect children from harm.

From these communications with them I have no doubt the proprietors of The Angel Totnes are safe, responsible and considerate in their management policies. I support their application for a Premises License and hope to make use of this venue for my own wine tasting events.

Prevention of crime and disorder: At the New Years Eve Party (22-23) I witnessed Angel staff refuse a man entry when he appeared to be drunk. Final orders for alcohol were clearly announced and enforced.

Public Safety: I rented the Angel one evening a week during 2021-2 (a non-alcohol event). I always found the place immaculate and stocked with fire extinguisher, first aid box, tap water and glasses. On one occasion I arrived to find the handrail on the stairs had been partly torn off by a previous renter. I reported this to Nicky Bell who had it replaced the next morning.

Prevention of Public Nuisance: At Holly Ebony's debut album live performance in January 2023 we were met by Angel staff at the door who told us we need to be mindful of disturbance to the neighbours, and there was signage to that effect as well. I noted that windows were firmly shut, loudspeakers pointed away from the street. We were asked to lower our voices and not hang around outside when leaving. Outside the Angel entrance on leaving I saw no sign of any rubbish, cigarette butts etc associated with the event.

Protection of children from harm: my wife and I took (aged 22) a Persian-origin family friend to a Persian feast event in December last year. She was asked to show ID when I attempted to order a drink for her.

And the possible negative views you may be getting because of a neighbour who does not want anything going on near her home. I understand I wrote something already, but I have been thinking about this now for a few days. And I really am shocked at the tone of the letter put through my door, hoping to get me to contact you to ask you to block their application. So having thought about this for a couple more days, I would like to add a few more thoughts.

I was born in Totnes 40 years ago, [REDACTED]. And, though I travel often, I have never lived anywhere else in England. In all these years, no business has ever sent me lovely notes letting me know what they were going to do, hoping I was ok with it, and inviting me to join in if I wished. Nicky and Claire are the only people I have ever met in the Totnes business world that have had the consideration to try to make sure people around them were happy. I do not think this kind of care would stop because they were given a license. It is not like that would turn them into different kinds of people.

In the letter suggested we complained because of her experience with the previous people that ran the Angel, how can I do that? The previous people have nothing to do with now. She also suggested that we complain citing prevention of crime, public safety, public nuisance and protection of children. This last point is appalling. Both Nicky and Claire are mums to really lovely daughters. They are wanting the license to host suppers, add to events that Totnes puts on that bring people into the town and help it to thrive, yoga, and the odd cinema even that is low key and in no way in competition with Totnes Cinema. As far as I have seen when I have visited, the patrons who go there are aged mid forties upwards, many in their 50's and 60's.

I would also like to say I have known Nicky in a professional capacity, she was my therapist and really helped me to deal with the death of my father, and without her help I really could not have coped. I found her utterly respectful and considerate then as well. I just cannot see how people who are adding to the town are being disrespected really. I also asked my neighbour if she had heard lots of noise before, she said she had never heard any noise at all, I have not either, and my our neighbours [REDACTED], sold really pretty dried flower wreaths there at the Angel for their Christmas fare. I have attended two events myself at the Angel,one being an evening of story telling with South Devon Story Tellers, the other being a concert by Holly Ebony. I have to say, having been the manager of a busy venue in Oxford in secular life, that I am impressed by the way that the Angel is being run. The events I have been to have been 'low key', well suited to the building and neighbourhood, with no over-crowding. Although alcohol is served, there was no sign of any excessive drinking and there were multiple non-alcoholic options on offer. Entrance and exit routes were kept clear and clearly indicated. Seating was well spaced to allow access and egress and the lighting was good. Venue staff were friendly and helpful and there were clear signs near the exit reminding people to respect neighbours and keep the noise down on leaving. I have to say – especially given the nature of the events I attended – you would be hard put to know there was an event going on in the building from the outside.

These are my personal experiences. I also know that the venue operated very well during the Totnes Festival week last summer though I was unable to attend there in person due to commitments at St.Mary's church which was also a venue for the Festival.

Event attendees are always reminded to be considerate to the surroundings when both arriving and leaving. There are always stewards present on the door to any of their busier/noisier events e.g. New Year's Eve and all involved are committed to keeping attendees safe, this includes making sure underage individuals are not permitted to attend events without a parent or guardian and would never be served alcohol. The venue also implements the Challenge 25 Policy requiring that anyone looking under the age of 25 is asked for photo identification to prove their age.

Without a Premises Licence, The Angel would be forced to drastically reduce the number of supper evenings they can host. to the times permitted. They check that insurances are in place and that if required the appropriate licence is in place. We had to cancel a sold out event due to us not holding the correct alcohol licence at the time of the event, this was later sought and given for a rebooked later event. Whilst The Angel team were very sympathetic to our plight they would not allow us to run a function without the correct paperwork in place.

This event in particular was a women-identifying only event and the door/access to the event was monitored, and those not invited were politely asked to leave, in order to maintain the ethos of the event and to create a safe space for attendees. The applicants adhered to a strict music-cut off time, as advertised, and I observed that attendees were being reminded to leave quickly and quietly, as was I.

Public safety

There is always plenty of free water available at events, and having checked with the applicants, I can confirm that there is a First Aid box available and staff are trained in safety procedures; staff levels are more than adequate, and access ways are clear/non-slip. There are fire extinguishers and regular glass collection.

Prevention of public nuisance

As I mentioned previously, I have been asked to leave The Angel quickly and quietly. There are notices at the exits to remind customers to leave quietly.

Though not a smoker myself, I have seen smokers directed around the back away from houses (and using the ashtrays provided).

All windows and doors are closed in The Angel when there are any music events. Additionally there are no speakers attached to the walls. There are no rubbish bins outside of the buildings: rubbish is contained completely away from public access.

Protection of children from harm

Children under the age of 18 are not allowed without their parents or a responsible adult at any of the evening events where alcohol is served. The Angel runs the Challenge 25 Policy which requires

that anyone looking under the age of 25 is asked for photo ID to prove their age. I have seen a 16 year old attempt to buy an alcoholic drink and be politely offered a non-alcoholic one instead.

4. STAFF TRAINING

All staff engaged in licensable activity at the premises will receive training and information in relation to the following:

- i. The Challenge 25 scheme in operation at the premises, including the forms of identification that are acceptable.
- ii. The hours and activities permitted by the premises licence issued under the Licensing Act 2003 and conditions attached to the licence.
- iii. How to complete and maintain the refusal register in operation at the premises (in relation to the sale of alcohol).
- iv. Recognising the signs of drunkenness.
- v. The operating procedures for refusing service to any person who is drunk, under-age or appears to be under-age, or appears to be making a proxy purchase.
- vi. Action to be taken in the event of an emergency, including reporting an incident to the emergency services.

Training shall be recorded in documentary form and shall be regularly refreshed at no greater than 12 month intervals. Training records shall be made available for inspection and copying at reasonable times upon request of an authorised officer of a responsible authority.

Training records will be retained for at least 12 months.
