I understand that Yealm Motor Services, Market Street, Yealmpton have applied for a license to sell alcohol from their garage shop.

I would like to oppose the granting of this licence on the grounds that it might lead to an increase in unruly behaviour in Market Street by providing increased access to alcohol by predominately young people who live in the neighbourhood. At the moment, alcohol is available to consume on the premises of two local public houses and it is also available from a local general store. In all these cases, the sale of alcohol is monitored in a responsible manner and unruly behaviour is rarely a problem. However, with a garage, it is possible that it will provide a focal point at which youngsters - many with motorcycles - might gather to buy and consume alcohol on the street. This could lead not only to unruly behaviour but also to dangerous behaviour if the drinkers are drivers too.

application.

At the moment, alcohol is readily available from 2 public houses, a Chinese restaurant, general store and farm shop and is kept under strict control so that unruly behaviour has not been an issue. However, with the possibility of alcohol being available at this site during the hours intended, this may lead to the area becoming a focal point for youths (young drivers & motorcyclists in particular) from other outlying villages, which could in turn cause alcohol fuelled public nuisance and dangerous behaviour. This will put pressure on local police resource in an area currently having very little problem.

Although CCTV is a requirement, this is not a preventative measure, only a tool for use after

any incident by which time the damage has been done.

I am also concerned about the effectiveness of the 'nominated supervisor' as he is not a member of the shop staff, but based in the workshop area next door and is unlikely to be around 16 hours a day, 7 days a week.

Yealm Motors Yealmpton – Application for an Alcohol Licence 6 am to 10 pm

I write as local member for Yealmpton to convey the concerns which have been expressed to me about the above licence application.

I am aware that Yealm Motors has applied for a planning application to extend their premises. However this alcohol application if approved will be valid in the existing building and in the new one if planning consent is granted. It is on this basis that I comment.

The application has led to serious local upset. I would want to appear at a hearing in order to expand upon the opposition.

The concerns are summarised below. [The licensing considerations are indicated].

The garage has a workshop and sells fuel. From the attached shop it sells newspapers, some groceries and the National Lottery. The present opening times are 0630 to 2000 Mo-Sat, 0730 – 2000 Sunday. The application is for 0600 – 2200. If the licence is approved is it intended that the facility will open for the extra hours?

 The staffing of the shop is by part time staff. In the evening they work alone, Will this continue? [Prevention of Crime and Disorder].

 Concern has been expressed about the availability on site of the appointed licence holder with the necessary training [Crime and Disorder, Public Safety].

 There are residential properties nearby. There are worries about disturbance from people leaving the garage at the end of the evening. There are similar worries for those seeking alcohol in the early morning. [Public Nuisance].

 There is a grassed open space beside the garage and a seat on the opposite side of the road. There is some history of people causing a nulsance around the seat in the summer. The fear is that this is more likely to happen with the availability of off sale alcohol. [Crime and Disorder, Public Nuisance.]

Mention has been made of the need for CCTV. Cameras
are not a deterrent to criminal activity. They may be useful as a tool to
after a crime but usually without success. [Crime and Disorder.]

I wish to raise my objections in respect of the Liquor Licence application at the above location. My reasons are as follows:

for 28 years.

When we moved here the garage was a relatively small business. Over the years it has gradually expanded and has developed into a busy retail outlet. This has increased the amount of activity on the site. There is a decision pending on extension of the premises, including a larger retail outlet with an intention to sell alcohol.

If a Liquor Licence was granted it would greatly increase the activity on the site especially because the present opening hours would be increased by 1 hour in the morning and 2 hours in the evening. This has the potential to cause the following problems:

- 1. Public nuisance as there will be more traffic in and out of the garage up to 10pm.
- 2. Availability of alcohol to teenagers and the possibility of noise and disorder in the vicinity.
- 3. The possibility of bottles and cans being deposited close in the area. this is already happening in the grassed area at the entrance to Elm Tree Park.
- 4. The alarm in the garage frequently goes off during the night and rings for long periods before being switched off. This is likely to be more frequent as the existence of alcohol on the premises could attract potential break-ins.

If a licence is granted it should be limited to fall in line with the Village Stores and close aty 8pm.

Councillor Keith Baldry has alerted Yealmpton Parish Council to this license application for the Yealm Motor Services, Market Street, Yealmpton.

Council debated this at length at the Council Meeting on January 12th 2015.

Yealmpton Council understand that a planning application has also been made to extend the shop attached to this garage which will lead to large choices of alcohol.

Council does not oppose this application in principle but does oppose the hours requested.

We are concerned that there is a real likelihood that these hours will lead to Crime and Disorder becoming a problem on the forecourt of the garage. This garage is within the curtilage of Yealmpton Village and we do not want Disorderly Behaviour to be created here because of excessive licensing hours. Opportunists may drive off in the dark without paying for the liquor thus leading to increased Crime.

Similarly, the sale of alcohol early in the morning and late in the evening is likely to lead to Public Nuisance within the village caused by excessive traffic to the 'off licence' and rowdiness and noise on the garage forecourt. Nuisance may also be caused by the effects of liquor being drunk on the premises immediately after purchase. We do not want drinkers sitting on the garage wall and 'partying' and creating a Public Nuisance to the local residents.

Therefore, Council requests that the licensing hours be restricted to the period from 8 am until 8 pm for any days approved by you.


